1. Awards of up to \$6,000 will be made for the academic year noted above. Scholarship funds are distributed directly to the school and in two equal payments for respective semesters.
2. Madden Merit Scholarship recipients must be enrolled as a full-time student (according to their educational institution), maintain a 2.75 GPA, attend an IPEDS accredited institution, and attend school for the entire academic school year. Funds can also be used for education at a recognized trade school leading to a professional certification or licensure.
3. Scholarship funds must be used for tuition, university assigned fees, books (in that order) for the academic school year noted above. Scholarships are void if not used for the stated purposes or in the allotted time frame.
4. The Denver Area Council has the right to change or modify this program in any manner, effective immediately and without notice.
5. The Denver Area Council Madden Merit Scholarship Awards are non-taxable according to the Internal Revenue Code. If they are deemed taxable by this entity, all taxes due are the responsibility of the recipient, including, but not limited to: FICA, local, State and Federal taxes.
6. The scholar's camp employment must be consecutive **and without interruption**. **Any interruption in employment will result in termination from the Madden Merit Scholarship program.**

**Requirement I – BSA Membership**

**Requirement II – Academic Progress**

I understand that a cumulative GPA below 2.75 will result in my termination from the scholarship program and that I must maintain full-time student status at my institution. I will ensure that an **official transcript** is sent to the Denver Area Council office by December 31<sup>st</sup> for the previous Fall semester and June 15<sup>th</sup> for the previous Spring semester. **Requirement III – Camp Employment**

I understand that I must be a camp staff member for two consecutive summers (one must be the summer of 2013) with favorable work performance, according to my camp director. Termination of a camp staff member, by either party, terminates the student’s eligibility for the scholarship. You must continue employment at one of the Denver Area Council Camps throughout the receipt of your Madden Scholarship funds.

The Madden Merit Scholarship Award is non-transferable. Madden Scholars who follow all requirements of the scholarship will submit and updated Continuation Agreement for each academic year they are in the program.

**Requirement IV – Communication**

All Madden Scholars will send a thank you note to John and Marjorie Madden each year they receive scholarship funds. Notes should be mailed directly to the Boy Scout office by **July 31, 2012**. They will be forwarded to John Madden’s office or given to them directly during a thank you presentation made at the Annual Madden Scholar Reception. We would also appreciate receiving your photo (“jpg” file) and a short biography about yourself each year to be included in our Madden Scholar Yearbook.





**Requirement V – Community Service**

Ten hours of Community Service, not related to Scouting, must be completed during the time frame of January 1, 2013 - June 1, 2013.
