Remembering Lakota Arrowmen Paul Miles, Ian White, & Matthew Ferrara

Paul Miles served Lakota as our 1998-1999 Chapter Chief. He also served as the Lodge Vice Chief of Camping Promotions in 1999. He earned the rank of Eagle Scout at 14 years old and was selected for the Vigil Honor in 1999. Also, Paul served a Lakota Medicine Man, Elangomat, Camporee staff numerous times, and he served at LLD. He was killed in a traffic accident.

First Lieutenant Matthew Ferrara, US Army, was killed in action by Taliban forces in Afghanistan. He earned the rank of Eagle Scout and was a former Lakota Arrowman. He was also a graduate of the United States Military Academy at West Point and from South High in Torrance. Gov. Schwarzenegger **ordered the state Capitol's flags flown at half mast.**

Ian White was a Lakota Arrowman who earned the rank of Eagle Scout in November of 2007 while simultaneously battling with cancer. In his troop, Ian served as the Senior Patrol Leader, Instructor along with other positions. Ian was very active in his local church and helped out with many groups and committees

All three of these young men demonstrated the character and selflessness we all hope to show as Scouts and as Arrowmen.
